Insured event: Under the present Contract, an insured event shall mean the occurrence of liability by the Insured according to the legislation of the Russian Federation as a result of injury or damage caused to the Beneficiaries' life, health and/or property, arising from defects in goods manufactured by the Insured or insufficient information on goods

Limits: Within the sum insured, The Insurer's liability limit for one insured event in the amount of:
12 195 (twelve thousand one hundred and ninety five) euro - for the harm caused to a private dwelling house;
32 520 (thirty-two thousand five hundred twenty) euro - for the harm caused to one many-storeyed building;
219 512 (two hundred and nineteen thousand five hundred and twelve) euro - for the harm caused to one industrial building.

Deductible: The present Contract establishes unconditional deductible in the amount of 815,00 (Eight hundred and fifteen) euro.
